- 4. Mere-appearing of name in the list of eligible candidates for written test does not qualify a candidate to be called for skill test. The criteria of shortlisting of candidate for skill test will be as per the University of Delhi rules.
- 5. The candidate is required to produce OBC-NCL certificate at the time of Skill Test which is valid for employment in Central Government Institutions for the year 2024-25. OBC candidate's eligibility will be based on Castes mentioned in Central List of Govt. of India. Their Sub-caste should also match with the entries in Central List of OBC, failing which the candidature shall be rejected and he/ she will not be allowed to appear in the Skill Test. The OBC certificate should clearly show that the applicant does not belong to the Creamy layer. The certificate submitted should be digitally verifiable.
- 6. Intimation to the individual candidate being called for the Written Test/Skill Test shall be sent via email and by display of schedule and list on the College website i.e. <a href="https://www.hansrajcollege.ac.in">https://www.hansrajcollege.ac.in</a>. It is the candidate's own responsibility to appraise himself/ herself with the schedule of recruitment events taking place by visiting college website regularly.
